WORKING GROUP PLAN OF ACTION - STRATEGIC PLANNING

Next steps for identified priority strategies and objectives for Action, under each of the key pillars:

a. Accessible Information

The Feral Cat Working Group will make available and act as a conduit for information and experience on feral cat management solutions.

The difficulty of progressing the proposed survey of stakeholders without the procurement of an Executive Office resource was discussed. It was agreed that the beginnings of a survey would be drafted ensuring alignment with agreed objectives. It may be useful to consider other feral cat surveys that have been recently conducted eg Zoos and Aquarium Association; Threatened Species Commissioner.

The FAQ Sheet is to be progressed.

b. Prioritised Research Program

A Feral Cat Research sub-group has been formed and was endorsed by the Working Group.

Discussions have commenced with BHP and the Southwest Biodiversity Partnership on potential research project collaborations.

c. Co-ordinated Management

The Working Group reconfirmed their priorities.

Discussion within the group on how to progress the concept of a Feral Cat Management Plan with general agreement that this would be a major project to be undertaken by the proposed Executive Officer. All members agreed that discussion of the WA Wild Dog Action Plan and it's relevance to the development of a WA Feral Cat Management Plan will be included as an agenda item for the next meeting. Members committed to familiarising themselves with the WA Wild Dog Action Plan before the next meeting.

A communications template was submitted and discussed. It was agreed that a Communications subgroup will be formed to work the template into a more comprehensive plan.
